1. **Besishahar Municipality, Office of Municipal Executive has allocated funds** towards the cost of **Chandi-Gausahar-Kaulepani-Purankot Road Upgrading Works** and intends to apply part of the funds to cover eligible payments under the Contract **BM/W/NCB/083/84/02**. Bidding is open to all eligible as per Section V of bidding document.
2. **Besishahar Municipality, Office of Municipal Executive** invites sealed bids from eligible bidders for the construction of **road upgrading works** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 61 Million**
 - Minimum Work experience of similar size and nature: at least One (1) Contract in Road Construction Work with a value of at least **NRs 16.3 Million**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. Sealed must be submitted to the office **Besishahar Municipality, Office of Municipal Executive, Besishahar Lamjung** by hand/courier before **12:00 PM** on **29th Asoj 2083**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **29th Asoj, 2083, 01:00 PM** at the office of **Besishahar Municipality, Office of Municipal Executive, Besishahar Lamjung**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 11,75,000**, which shall be valid for 30 days beyond the validity period of the bid **120 days from bid opening**.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
