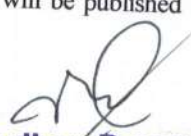

Office reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever. the terms and condition not covered here will be in accordance to PPA-063 & PPR 2064.
- 5) The bids will be opened in the presence of Bidders' representatives who choose to attend at on 2083-06-29 (15th Oct 2026) at 13:00 hours at the office of Besishahar Municipality, Besishahar, Lamjung.
- 6) Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amount which shall be valid for 30 days beyond the validity period of the bid.
