1. **Besishahar Municipality has allocated funds** towards the cost of **Chandi-Gausahar-Kaulepani-Purankot Road Upgrading Work** and intends to apply part of the funds to cover eligible payments under the Contract **BMW/NCB/082/083/11**. Bidding is open to all eligible as per Section V of bidding document.

2. **Besishahar Municipality** invites sealed bids or electronic bids from eligible bidders for the construction of **Chandi-Gausahar-Kaulepani-Purankot Road Upgrading Work** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 29.2 Million**,
- Minimum Work experience of similar size and nature: **One Road Construction Work including bituminous pavement works of amount equal to NRs 7.8 Million**

3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Besishahar Municipality, Besishahar, Lamjung, Gandaki Province, Nepal** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below.

6. Pre-bid meeting shall be held at **Besishahar Municipality, Besishahar Lamjung** at **2025-11-23, 02:00 PM**.

7. Sealed or electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **2025-12-05**. Bids received after this deadline will be rejected.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** on **2025-12-05** at the office of **Besishahar Municipality Office, Besishahar Lamjung**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 5,62,500** which shall be valid for 30 days beyond the validity period of the bid.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
